SOUTHERN POVERTY LAW CENTER INDICTED FOR FRAUD

Once again, the Democrats and their organizations are at the center of an indictment for alleged fraud and money-laundering. What is it with these people? Think of Hunter Biden, Congresswoman Sheila Cherfilus-McCormick of Florida, the California Medi-Cal scheme, the rampant fraud in Minnesota, the Democratically controlled NGO's that receive government funds and then funnel money to various Democratic organizations, the Clinton Foundation and their alleged pay to play scheme, and the list goes on and on:

- Democrat Rep. Sheila Cherfilus-McCormick and several co-defendants were recently indicted for stealing \$5 million of federal disaster funds, laundering the proceeds, and using the money to support her 2021 congressional campaign.
- ActBlue, a Democratic Party political action committee (PAC), is being investigated for misleading Congress on vetting foreign donations. Since its inception in 2004, ActBlue has been a major part of the Democratic Party infrastructure, and has raised over **\$16 billion** for Democratic candidates and causes. A recent headline in the New York Times stated, "***ActBlue May Have Mised Congress on Vetting Foreign Donations, Its Lawyers Warned***". In the report issued by the house committees investigating ActBlue, "the five current or former employees at ActBlue who appeared for depositions all invoked their Fifth Amendment right against self-incrimination during

questioning - for a total of 146 times....By March 2025, every member of ActBlue's legal and compliance team resigned, was fired, or went on extended leave from the platform".

- Georgia's Fulton County State Prosecutor Fani Willis hired and paid her lover Nathan Wade over \$600,000 to prosecute Trump in an election interference case. She was removed and disqualified from prosecuting the Georgia election-interference case and was ordered to pay attorneys' fees after judges found procedural and ethical violations by her office.
- Rep. Ilhan Omar filed an amended congressional financial disclosure that slashed her household's reported assets from as much as \$30 million to a range of \$18,004 to \$95,000, and "her office says the original eye-popping figure was simply an accounting mistake".

However, nothing meets the egregiousness of the Southern Poverty Law Center. As reported by various media groups, the SPLC deliberately tried to foment racial hatred by infiltrating and secretly funding the actions of "hate groups" such as the KKK, and then turned around and asked for financial donations to stop their hatred. According to FBI Director Kash Patel, "the SPLC allegedly engaged in a massive fraud operation to deceive their donors, enrich themselves, and hide their deceptive operations from the public".

In a statement by acting U.S. Attorney General Todd Blanche in announcing the indictment, "The SPLC is not dismantling these groups. It was instead manufacturing the extremism it purports to oppose by paying sources to stoke racial hatred".

Under the Trump administration, it seems the organization is finally being exposed. You may recall their targeting of Charlie Kirk's organization Turning Point USA. SPLC had named TPUSA as a hate group in its 2024 annual report, placing the organization on its list of extremist-designated groups. Charlie Kirk was assassinated just months after the SPLC had placed TPUSA on its "hate map."

Other conservative groups that appear on SPLC's "hate map", include PragerU, Moms for Liberty, the Family Research Council, Act for America, Focus on the Family, among dozens of other mainstream conservative political action groups.

"Few organizations have sown more hatred against fellow Americans than the SPLC itself," Heritage Chief Advancement Officer Andrew Olivastro told The Daily Signal in a statement Friday. "It doesn't fight hate—it manufactures it, embedding division into every press release they issue and every word they post; their business model is defamation, and America is finally waking up."

As opined by American Thinker, "It seems with this indictment the DOJ has started down the path of dismantling this front organization for the Democrat party that has done so much to manufacture narratives for the Democrats to use in demonizing and jailing their opponents." We can only hope that the Southern Poverty Law Center, used extensively by the liberal media as a source for their biased reporting, will finally be dismantled.
